# Macomb County Bar Foundation College Scholarship Application



Applicants for the Macomb County Bar Foundation Trustees Scholarship must be enrolled or accepted for enrollment at Macomb Community College at least part time (six credit hours)

- Preference to students who are returning to school due to job loss resulting from downsizing, restructuring, lay-off or corporate buyout
- Preference to students who seek to adjust skills by enrolling in a law related education program
- Award is for tuition, fees and other educational expenses

Applications for this scholarship will be accepted at Macomb Community College Financial Aid Office by the third Wednesday in January. This scholarship will be formally presented to the recipient in the spring.

The application packet must include:

- Completed application
- One to two page brief summary of applicant's educational and career goals
- Resume
- Three letters of recommendation
- A personal statement in which the candidate discusses their interest in law, Macomb County, reason for applying for scholarship, career goals and any other pertinent information he/she would like the Scholarship Committee to know about.
