Angela served on the Board of Directors in 2017-2018 when she was chair of the Woman Lawyers Association of Michigan - Macomb Chapter and was also elected to a three year term by the membership. Dana Freers was re-elected to serve a second three year term and Lori Smith was elected as your Treasurer for 2019-2020. Lori's election has left a vacancy on the board that will be filled by appointment.

It truly is an exciting time to be a part of the Macomb Bar. We are not the same bar we were just a few years ago and member centric positive change continues to be rolled out every month. If you have ever considered getting involved with bar leadership, now is the time to send in your Letter of Interest (see page 9 for details). Serving on the Board is more than attending a dozen meetings a year. It involves a willingness to understand issues that surround the various practice areas that our members engage in. It involves an awareness of trends, technologies, policies and best practices that make membership associations relevant and enduring to members. It takes a deeper understanding of the organization's mission, current and changing demographics, it's partnerships, successes, failures, and vision for improvement. It also takes a passion for the profession and a willingness to prepare to lead.

Constantly learning, constantly improving is what the Macomb Bar has been up to over the past year. New partnerships have improved our seminar offerings, rebuilt our lawyer referral service and rejuvenated our public outreach over the past year. The most recent change is the association's new membership dues structure. A 2012 Board approved membership dues increase was slated to begin in 2017 but was put off until we could study our membership demographics and complete a comparative analysis of like-sized bar associations across the country. The result is that the board reduced the number of membership categories from nine to five, added a new Associate Membership for Businesses and, following the example provided by many bar associations, adopted an optional Sustaining Membership that comes with a plethora of additional benefits. It was important to everyone to continue to support the Macomb County Bar Foundation so it was agreed that 50% of Sustaining Dues will be contributed to the Foundation.

Another change, based on members request is the opportunity to auto renew each year through our LawPay credit card system. Which, by the way is the best merchant account program available for law firms. If you are looking to improve your receivables, contact Janelle Benefeld at <u>jbenefield@</u> <u>affinipay.com</u> and tell her that you are a proud member of the Macomb Bar!

In June you were mailed a Membership Renewal form. If you haven't received the renewal for its members, professional organizations need a diversity of people, ideas, energies, talents and leadership styles. So now is the time to reach out to friend and reach across the table and ask opposing

Circuit Court Corner




